- Accelerated vesting of the reporting person's restricted stock units pursuant to the FADV 2003 Incentive Compensation Plan. The restricted units vested immediately prior to and in conjunction with the merger of 11/18/2009.

3. Between February 17, 2005 and October 27, 2005 the reporting person acquired 343 shares of FADV common stock under the FADV 401(k) plan.
4. Between October 27, 2005 and February 15, 2006 the reporting person acquired 65.45 shares of FADV common stock under the FADV 401(k) Plan
5. Pursuant to the merger, stock options to acquire Class A common stock of First Advantage Corporation (FADV) were assumed by the First American Corporation (FAF) using a ratio of 0.58 of a common share of FAF per share of Class A common stock of FADV.
6. The consideration received in the merger was 0.58 of a common share of The First American Corporation for each Class A common share of First Advantage Corporation common stock, plus cash in lieu of any fractional shares.
7. Disposition of previously reported restricted shares as part of the First American exchange offer.
8. The consideration receive in the merger was 0.58 of a common share of The First American Corporation for each Class A common share of First Advantage Corporation common stock.
